# Response to prevention of the spread of COVID-19 at the 152<sup>nd</sup>-term Ordinary General Meeting of Shareholders

We would like to take this opportunity to thank you for your continued support of our operations and business.

We will hold the 152<sup>nd</sup>-term Ordinary General Meeting of Shareholders (hereinafter called the "General Meeting of Shareholders") on Thursday July 30, 2020 as you have been notified, but this is to inform you of our requests mentioned below to prevent the spread of the novel coronavirus (COVID-19) giving top priority to your health and safety. We would appreciate your understanding and cooperation in this regard.

## [Requests to shareholders]

- •We would like you to be mindful of the COVID-19 infection status and kindly ask you to refrain from coming to the venue on the day of the General Meeting of Shareholders.
- •Since you are able to exercise your voting rights in advance by voting card (postcard) or the Internet, etc. for the General Meeting of Shareholders, please actively use the alternative ways of exercising voting rights. Please see page 2-3 of the convocation notice for details.
- •The General Meeting of Shareholders will be streamed live on the day. Therefore, you may view the General Meeting of Shareholders without coming to the venue (Please see the back for details).

#### [Requests to those shareholders coming to the venue]

- •When you come to the venue, we ask for your cooperation in wearing a face mask and disinfecting your fingers.
- •We will measure your body temperature by a thermography at the entrance of the reception. Those shareholders who have a body temperature of 37.5°C or above, and who seem to be in a bad physical condition may be asked to refrain from coming into the venue.
- •To reduce a risk of contact infection, seats are spaced out in the venue. Consequently the number of seats is limited. We may restrict entry into the venue due to the limited number of seats.
- •From the standpoint of preventing the spread of the COVID-19, proceedings of the General Meeting of Shareholders are to be shorter than those in the past. Please be advised in advance that we take one question from one shareholder.
