Olympus Acquires ISO 14001 Multi-site Certification for 12 Group Companies

Olympus Corporation (President: Yasuo Takeuchi) has obtained ISO 14001 environmental management systems certification for 12 group companies in Japan and elsewhere in Asia.

The Olympus group has been working to elevate its environmental performance under the Olympus Group Environmental Policy, led by its environmental management functions at Olympus' global headquarters. Through continuous improvements in its environmental management system, the Olympus group has obtained ISO 14001 certifications for each major domestic and overseas production facility, as well as logistics and sales subsidiaries (27 companies as of September 2020).



Acknowledging the necessity to establish the environmental management system across the entire value chain, including product development, procurement, manufacturing, logistics, sales and repair, Olympus is enhancing environmental governance of the group, streamlining environmental management, and promoting the integration of ISO 14001 certifications.
